Rocky Mountain Artists' Safety Alliance and Colorado Theatre Guild present Staging Theatre Intimacy: A Conversation on Community Standards

Please join us for an informational panel and workshop sponsored by the Colorado Theatre Guild and Rocky Mountain Artists' Safety Alliance (RMASA) focused on Staging Theatrical Intimacy best practices and how to incorporate safely staging intimacy in your productions. A Zoom link and recording will be available during and after the event for those who cannot attend on-site.

This 90 minute session will provide participants with an overview of the Community Standards for Theatre and specific tools/practices to take back

to rehearsal, auditions, and performance. Leaders of the workshop will share techniques learned and implemented in the Colorado theatre community and provide participants with opportunity to practice, experience the work, and connect with others who are learning.
